MHP provides details on officer involved critical incident in Big Timber

Two Montana Highway Patrol troopers were involved in an officer involved critical incident Thursday afternoon outside of Big Timber. The situation occurred after troopers were alerted that a suspect from Nebraska, with a no-bond warrant for his arrest for threatening to use explosives or place bombs, had entered Montana.

At approximately 2:48 pm a trooper notified dispatch that he had located the male suspect's vehicle near Big Timber and a second trooper, who was in the area, was called for backup. Minutes later, the trooper initiated a traffic stop and advised dispatch the suspect was fleeing. The trooper subsequently attempted to perform a precision immobilization technique (PIT) maneuver to stop the suspect's vehicle but was unsuccessful. After the PIT attempt, the troopers advised that shots were fired by the suspect and the troopers had returned fire. Soon after, the troopers advised the suspect was down. The incident lasted approximately three minutes.

The suspect, who was considered suicidal, armed, and dangerous, was pronounced deceased on scene. The two troopers involved are uninjured and have been placed on administrative leave per MHP's standard policy.

The Sweet Grass County Sheriff's Office arrived on scene to assist shortly after the incident. The Division of Criminal Investigation (DCI) will lead the investigation.

"Without our troopers' quick thinking and bravery this incident could have been much worse. I'm confident that DCI will conduct a thorough investigation. Our partners at the Sweet Grass County Sheriff's Office have also been incredibly helpful on scene," MHP Colonel Kurt Sager said.

Finance Committee March 31, 2020

Council members Present: Ms. Diane Armstrong, Ms. Mary Jo O'Rourke, Mr. Russell Schwandt.

Mr. Wendland's statement: Committee had a discussion on gathering information and ways to pay Wendland's bill presented to the council on March 14, 2025. Councilman Schwandt suggested that all itemized invoices pertaining to the charges be provided. Mr. Schwandt stated that a payment could not come from the taxpayers' so it would have to come from somewhere else like a bond or a mill levy. Ultimately it will be paid by taxpayers.

Council lady O'Rourke stated that she didn't believe that this was the council's fault but that they don't have the expertise to get through the issue. She stated she had reached out to some planners for advice.

Chairman Schwandt ask the mayor if he would get some cost bids from planners. He asked if the committee could set up a meeting for April 11, 2025 at 8 a.m. to review the data, prepare it to go forward to council.

Mr. Wendland explained that all the information was in his personal financial records and that if the meeting on March 14, 2025 had been closed, he would have presented it. **Question:** Does Mr. Wendland have the itemized records the city is asking for?

Mike Klakken asked the finance committee if they had a copy of the original contract provided by City Attorney Dolan and if they had read it. It appears this contract was not provided in the packet at March 14th council meeting when Mr. Wendland presented the statement for \$517,856.06±.

Note: There was a signed contract, a binding agreement by all parties involved. A contract is a legal document to explain the details of an agreement. **Question:** Why is the council not working with this legal agreement? What is the importance and why did the city pay an attorney to have the contract drawn up if it was not needed?

Montana Western Transfers Vigilante Field Ownership to Beaverhead County High School

The University of Montana Western has officially transferred ownership of Vigilante Field to Beaverhead County High School, marking a new chapter in a partnership that has spanned over 75 years.

With the completion of the new Bulldog Stadium, the Board of Regents of the Montana University System (MUS) approved the transfer earlier this academic year, which was officially recorded on March 7, 2025, by Flying S Title & Escrow.

"Montana Western is thrilled to take this next step in our long-standing partnership with Beaverhead County High School," said UMW Chancellor Michael Reid.

While Vigilante Field is now under BCHS ownership, Montana Western will continue to use the track for its Track and Field program.

"Having Vigilante Field officially titled to the high school is very exciting for us," said BCHS Superintendent, Megan Conrow. "This stadium holds a special place in our school's history. We are so thankful and appreciative of everyone who worked on this to ensure that Vigilante Stadium can continue to be a cornerstone of BCHS school spirit and tradition for generations to come."

The Beavers and Bulldogs have had a long tradition of success on Vigilante Field. The last year that UMW and BCHS shared Vigilante Field, BCHS won a state football title and UMW won the Frontier Conference Championship for the first time since 1994, followed by another Frontier Conference Championship win in 2024 in the new Bulldog Stadium.

"Having the opportunity to support the continuation of the legacy of Vigilante Field at BCHS and to create an additional community facility with Bulldog Stadium at UMW has been incredible, and it's an exciting time as we look to the bright future ahead for both schools," said UMW Foundation Executive Director and BCHS School Board Member, Roxanne Engellant.
